1. Place the connector of the cable in the hole in the lower part of the ProClip. Carefully press the connector downward and forward so it passes the locking and goes into the hole. Press until you hear/feel the connector snap into place in the holder. Loosen the screw in the center of the holder so you can remove the tilt swivel attaching plate on the back.



2. Place the base plate over the matching holes in your mounting bracket (demo ProClip mount shown in picture) Attach the base plate by using the self-tapping screws.

Place the holder onto the base plate and attach it firmly with the center screw. Then loosen the screw slightly for easier angling/rotation of the holder.



3. To place the device in the holder: Place the upper part of the device in the upper part of the holder and press it upward so the top part of the holder slides upward. Press the lower part of the device forward into the holder. Set the device down onto the Lightning connector. To remove the device from the holder: Press the device straight upward so the top part of the holder slides upward. When the device is set free from the connector, pull the lower part of the device toward you and slide the device downward out of the holder.



4. The holder and phone is in place. Switch between portrait and landscape view by rotating the holder to desired position.

## Returns
