**Do not** attach anything to the mount face plate until after installing the mount to the dashboard. Doing so makes it more difficult to install the mount to the dash and non-refundable since you have screwed into it.

This mount extends approx 1 inch/ 250 mm from the air vent so it can easily be adjusted. The mount does not block the air flow. The air flow will simply be re-directed on each side for the mount.



1. Use the enclosed alcohol pad to clean the area where the ProClip is to be installed. Peel off the cover of adhesive tape on the ProClip. Note: The adhesive tape does not leave any marks or damage the dashboard, and it is easy to remove. Place the ProClip in your hand so the ProClip label (sticker) is in an upright position, or if vertically positioned; the P in ProClip is at the top. Press the thin angled edge on the lower part of the ProClip into the seam/gap between the air vent and the surrounding panel frame.



2. Press firmly down on top of the ProClip so it flexes downward. Then hook it into the seam/gap between the air vent and the surrounding panel frame. Release the pressure on top of the ProClip.



3. Place your finger underneath the ProClip and press upwards to make sure the angled edge is all the way into the gap.



4. The ProClip Mount is in place.
